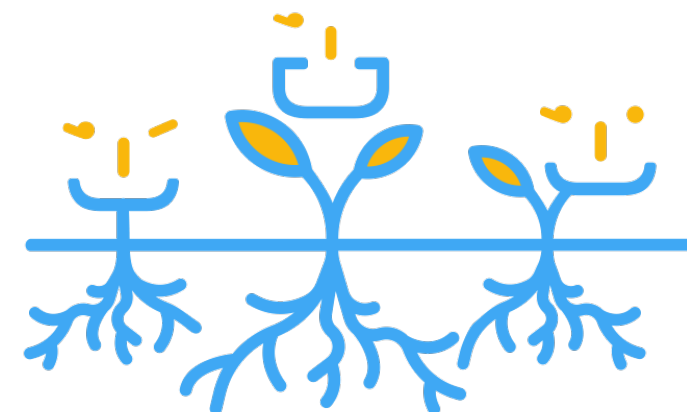

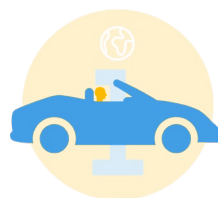

1) TRANSMISSION OF THE VEHICLE LICENSE PLATES

You send us a list of the license plates associated with a traffic violation in a secure e-mail/via Google Drive (or another secure alternative) via Excel.

We also need the data on the traffic violation and the associated photos from you in order to be able to start our process after determining the holder.

2) HOLDER DETERMINATION

We determine for you the holders of the vehicles throughout Europe who are associated with a traffic violation.

SENDING THE FINE PAYMENT REQUESTS MODERN & WORLDWIDE!

3) PAYMENT REQUEST

If the traffic offender has not yet received any information about the violation (e.g. in the case of parking lots monitored by cameras), we will start the process with a payment request under your letterhead.

The letter is written in the **respective national language** of the **traffic offender**. We integrate the **contact details of Taxaris** in order to be able to answer possible queries from illegal parking offenders.

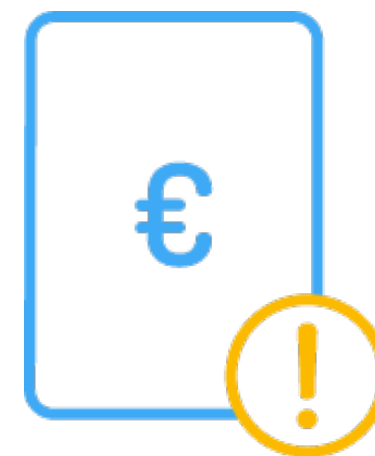


DUNNING PROCEDURE BY US

4) DUNNING

If your debtor has already been informed of the violation (e.g. by ticket), the procedure starts with the payment reminder. If this is not the case, the **payment reminder** follows the payment request. In the event of persistent non-payment, the **reminder** follows as a second letter in the dunning process.

Your debtors will be asked in the **respective national language** to pay the main claim, the costs for determining the owner, a reminder fee and a country-specific processing fee.

5) COLLECTION

If the claim is not settled even after the dunning process has taken place, selected **collection partners** from DEMONDO's **international partner network** will start the collection process from debtors based abroad. Our sister company "Taxaris" takes over the collection process throughout Germany.

The debt collection specialists approach your debtors in order to collect the **outstanding receivables for you**. Reporting is done via DEMONDO.
