
How It Works:

Simplified Steps for Seamless Payments

As the newest addition to the SPARK Self Service Portal, Scan to Pay isn't just an option—it's the essential payment layer for Ticketless and Free Flow. By combining simplicity for drivers with operational efficiency for operators, it anchors the next generation of parking solutions.

Here's how it works:

- **1). Enter** Driver enters with Ticketless or Free Flow technology; the license plate recognition camera captures the parker's license plate.
- **2). Scan** QR codes placed on signage connect parkers to payment portal page where they enter their license plate number and preferred form of payment.
- **3). Exit** License plate is captured upon exit and payment is validated automatically, enabling a smooth departure.
- **4). Confirm** An option of a digital receipt is available by the parker scanning a QR code upon exit device or via exit signage.
